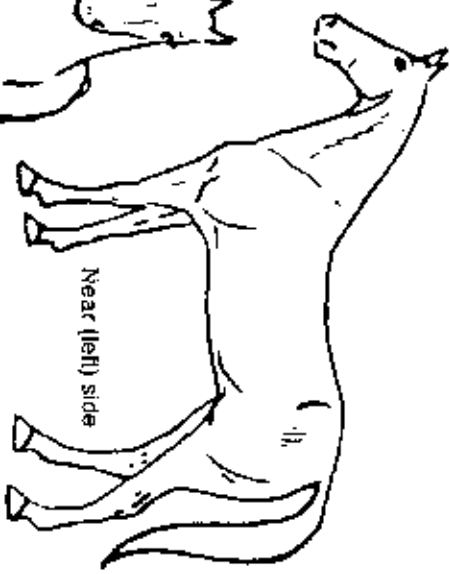

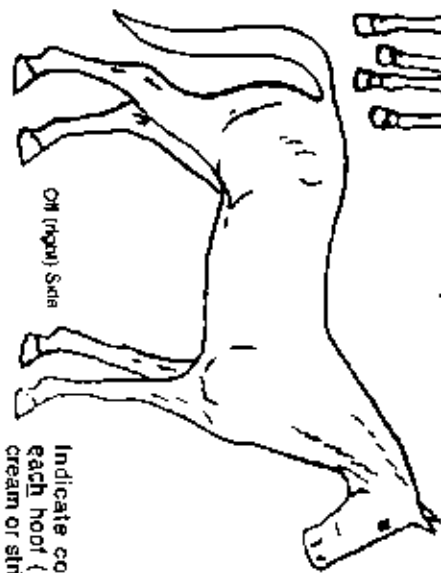

RULES OF REGISTRATION FOR FOUNDATION HORSES

Only horses of McCurdy ancestry shall be accepted as foundation sires and dams.

1. They must be traced back to McCurdy's Doctor and foundation mares or back to horses that are publicly known to be McCurdy's.
2. All horses that meet the above requirements must then meet the breed standard relative to physical conformity, temperament and natural gait.
3. In the event a stud or mare meets all other requirements but is known to carry a percentage of other genes (such as Tennessee Walking horse), the pedigree should show such even to the extent of ancestors' names and registration number.
4. Only studs and mares shall be accepted as foundation horses. The letter F shall precede the number assigned foundation horses.
5. Any horse registered or eligible for registration in the Tennessee Walking Horse Breeder's and Exhibitors Association Registry, or any other gaited horse registry, must be proven genetic lineage to the McCurdy foundation in their registration documents in addition to meeting the standards of physical conformity, temperament and natural gaited ability.
6. In order to be registered as a foundation sire, one of the following must exist:
 - A) A gray stud of known McCurdy ancestry, or
 - B) A stud with proven lineage (documented through existing Tennessee Walking Horse Breeders & Exhibitors Association Registry) to be within four generations of McCurdy's Fox 419353 or McCurdy's Doctor F-79 and carry gray characteristics in color, or
 - C) A stud with proven lineage (documented through existing Tennessee Walking Horse Breeder and Exhibitors Association Registry) having a substantial influence of descendants from McCurdy's Doctor F-79 and McCurdy's Fox 419353 on both the sire and dam pedigree and carry gray characteristics in color.

Gray characteristics are defined as unusual gray markings on the hips and around the head of the tail, combined with definite black points below the knees. Gray characteristics may be present at birth or may develop and become more obvious with age.

7. To register any stud or mare as a foundation sire or dam, at least one director of the registration office must personally see the horse in question, see them worked under various conditions to the point of being able to ascertain temperament and physical conformity as well as gait. Then a video tape must be made that shows the horse gaiting on uneven footing, as well as under ideal conditions. A copy of the video tape shall be sent to the registrar. All directors must agree to accept horse in question. Each director has veto power and any one that objects will deny the acceptance of the horse as a foundation animal.

8. All horses, both studs and mares, must be at least two years of age and broke before being considered for registration as foundation horses. In case of their being bred before they are registered foundation horses, once they have achieved registration status, the offspring may be pedigree registered providing the other parent is registered. If the other parent is not registered, then the offspring must follow the path of all foundation horses to registration. (See rules on back of Application for Partial Registration).

9. A color photo(s) showing front and one side of horse must be attached to application.
