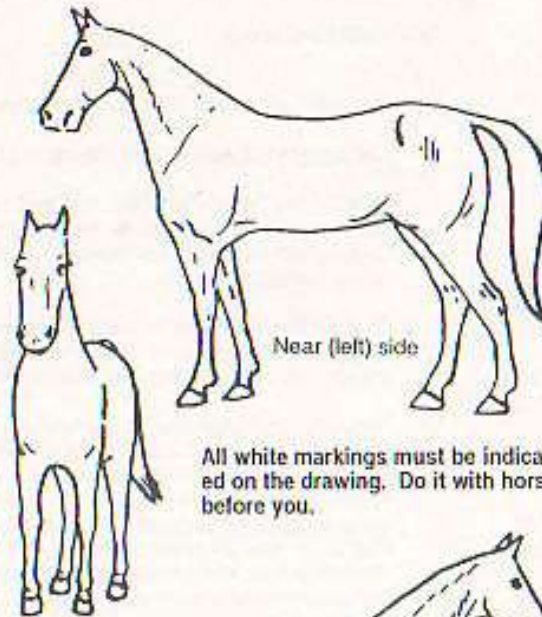

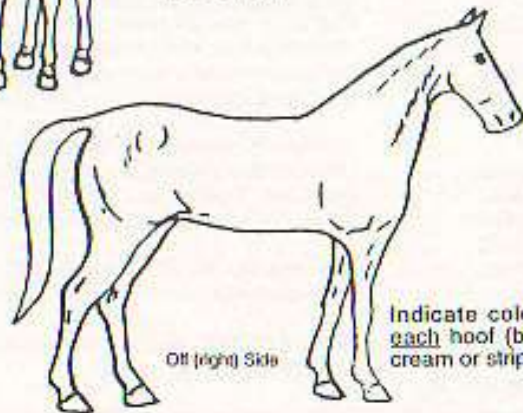

## PEDIGREE REGISTRATION REQUIREMENTS

### Full Pedigree Registration

1. Breeders Certificate by Stallion owner required.
2. The progeny of a registered Stallion and a registered Mare.
3. HORSES TO BE REGISTERED, sired by a registered McCurdy Stallion out of a registered McCurdy Dam, must have on the application for registration the name and number of both sire and dam. The signature of owner of sire on a completed Breeder's Certificate and the signature of owner of dam at time of service and time of foaling is required.

In case either or both are deceased, then signature must be provided by someone authorized to act for them. It is, therefore, important to secure such signatures before sending application to the Registry Office. It is recommended that Breeders' Certificate be obtained at time of breeding.

4. Both colts and fillies must be registered with McCurdy Plantation Horse Registry before their six month birthday or follow the basic foundation horse registration procedure. Registration application may be obtained from the registration office. These applications must be signed by the mare owner, and a Breeder's Certificate signed by the sire owner must be attached to the Application. A video of the colt or filly gaiting along side of its mother must accompany application. If the colt or filly does not show natural gait, registration will be denied; however, application may be made at a later date under foundation registration rules. A copy of the video will be kept on file so the horse can be compared with the video as long as they live, should a question of their identity arise. In addition, a color photo(s) showing front and one side of horse must be attached to application.
5. Transfers are required with applications for registration of foals when the dam of the unregistered foal was owned at time of foaling by someone other than the owner of the foal when the application for regulation is submitted. Transfers must be attached to such applications for registration, date of purchase filled in and fee paid for both registration and transfer.
6. It is necessary that the Registry be notified when stallion is gelded, giving date of same. Furnishing the Association with this information will give data as to the age foals must be when sired by this stallion.
7. Name of any McCurdy Horse can be changed, (1) upon payment of fee and (2) provided it has no registered McCurdy foals.
8. Application to recognize a change in color may be made before horse is three (3) years of age. A color photo must be submitted with a new application form and original registry certificate. Horse may be subject to inspection by a Registry Official.
9. Please look over the paper carefully before mailing to the Secretary, and be sure that you have proper information, dates, marking, signatures, etc.
10. Any person who shall willfully register or record a false pedigree, shall be forever barred from making further registrations, and the registration of such false pedigree shall be cancelled. Certificates obtained by fraud or misrepresentation will be cancelled, and future certificates denied the offending party.
